Non renewal of the certificate within the time limit will result in loss of eligibility for insurance coverage and appropriate legal action by the local self Government/ Revenue Department.** All Officers and above the rank of Station Officers of the fire and rescue service department will have the right to inspect the building on any day/time after serving seven (7) days notice to ensure that the installed systems are in good working condition.
